I S. 1426), last modified by art. 1 of the law of 30 June 2017 (BGBl. I p. 44), paragraph 30 and 31.
- The cardboard quality also complies with the recommendation XXXVI "paper, cartons and cardboard for food packaging" of the "Bundesinstitut für Risikobewertung", 34th notification, federal law gazette 10, 14 (1967), including the 222nd memorandum, Federal Health Journal 63, 133 - 134, state of 9 January 2020. The cardboard quality (qualities) may stand in direct contact with dry and greasy foodstuffs*. No comments are given on the technical suitability of the requisite concerned.
- Furthermore the cardboard quality complies with the requirements of the resolution of the European Council AP (2002) 1 about paper, cartons and cardboard for food contact of 17 September 2002, whereupon instead of the techn. doc. 1 which is not implemented up to now, the stated list of factory additives of the recommendation XXXVI of the German "BfR" have been consulted.
- The cardboard quality mentioned herein also complies with Austrian regulations particularly with the food packaging regulations (LMSVG of 20 January 2006, BGBl. I, no. 13/2006).
- The provisions of the regulation (EC) No. 1935/2004 of the European Parliament and the Council of 27 October 2004 as well as of the regulation (EC) No. 2023/2006 of the European Parliament and the Council of 22

December 2006 concerning materials and articles, which are intended to be brought into contact with foods, are therewith fulfilled.

We can confirm that no mineral oil aromatic hydrocarbons have been detected (detection limit 5 mg/kg)

FLUORIDIZED SUBSTANCES

(Danish Order on food contact materials nr. 681 25 May 2020)

This product is manufactured without any fluoroinated polymers and therefore also without fluorinated compounds. Current measurements of the total organic fluor content showed levels below the proposed indicator value of 20 µg organic fluoride/g of paper.

Currently no methods are available to determine migration of the traces present.
